# About Wizardia

Wizardia is a Play-to-Earn (P2E), online role-playing strategy game built on three core gameplay pillars:

- innovative, turn-based combat.
- player decision-driven game evolution.
- base-building with sophisticated economy model.

In line with exciting, new technologies, we have designed the Wizardia world, with Non-Fungible Tokens (NFTs) acting as its very core.

These NFTs are completely unique virtual assets that have both in-game purposes and hold real-world value outside of the virtual realm.





## How to earn?

### Cashback Wizardia Tokens (\$WZRD)

A utility token that also acts as a currency that can be earned and spent within the game itself.

### Time Investments

Farming or producing valuable in-game resources and selling them for Wizardia Tokens to other players.

### Wonder Constructions

Realm Wonders are NFT buildings that act as a source of power and passive income. They also come as Founder's NFTs.

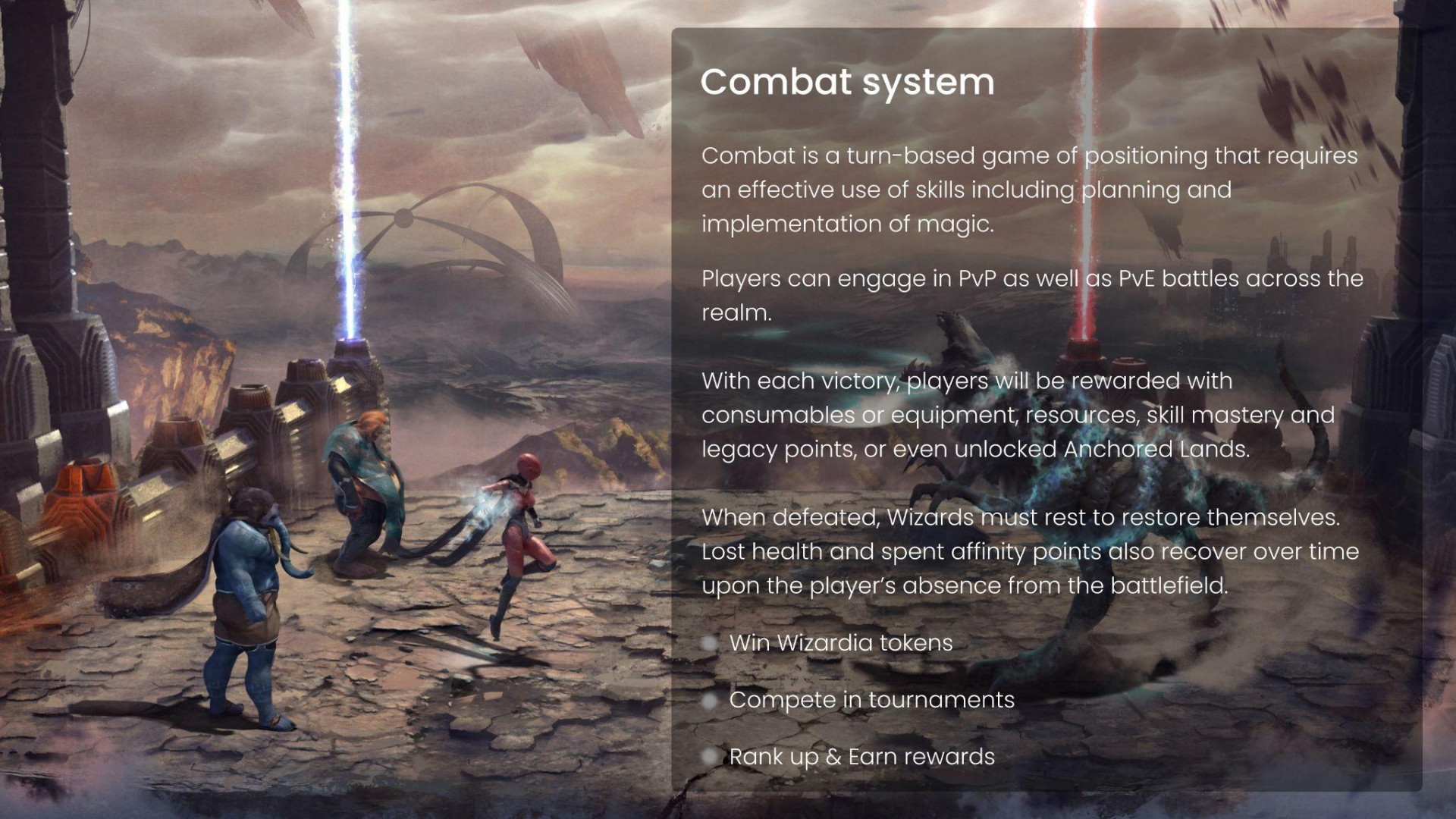
### Powerful Wizards

Increasing power and value of your Wizards (in-game characters) through tasks, and trading them as an NFT or leaving their legacies to successors.

### Protopell Discoveries

NFTs that players can take advantage or sell.

## Combat system

Combat is a turn-based game of positioning that requires an effective use of skills including planning and implementation of magic.

Players can engage in PvP as well as PvE battles across the realm.

With each victory, players will be rewarded with consumables or equipment, resources, skill mastery and legacy points, or even unlocked Anchored Lands.

When defeated, Wizards must rest to restore themselves. Lost health and spent affinity points also recover over time upon the player's absence from the battlefield.

- Win Wizardia tokens
- Compete in tournaments
- Rank up & Earn rewards



# Base building

Players who own an Anchored Land can custom build a base for their Wizards to call home and will earn a passive income of tokens and resources.

Different buildings serve different purposes that will influence building strategy.

Some Anchored Lands give the player a source of passive resource farming, while others are required to produce Spells from resources (or could even unlock other capabilities such as trading and fast-travel).

- Grow crops
- Farm resources
- Fight lurking threats
- Build, expand and explore



# Crafting

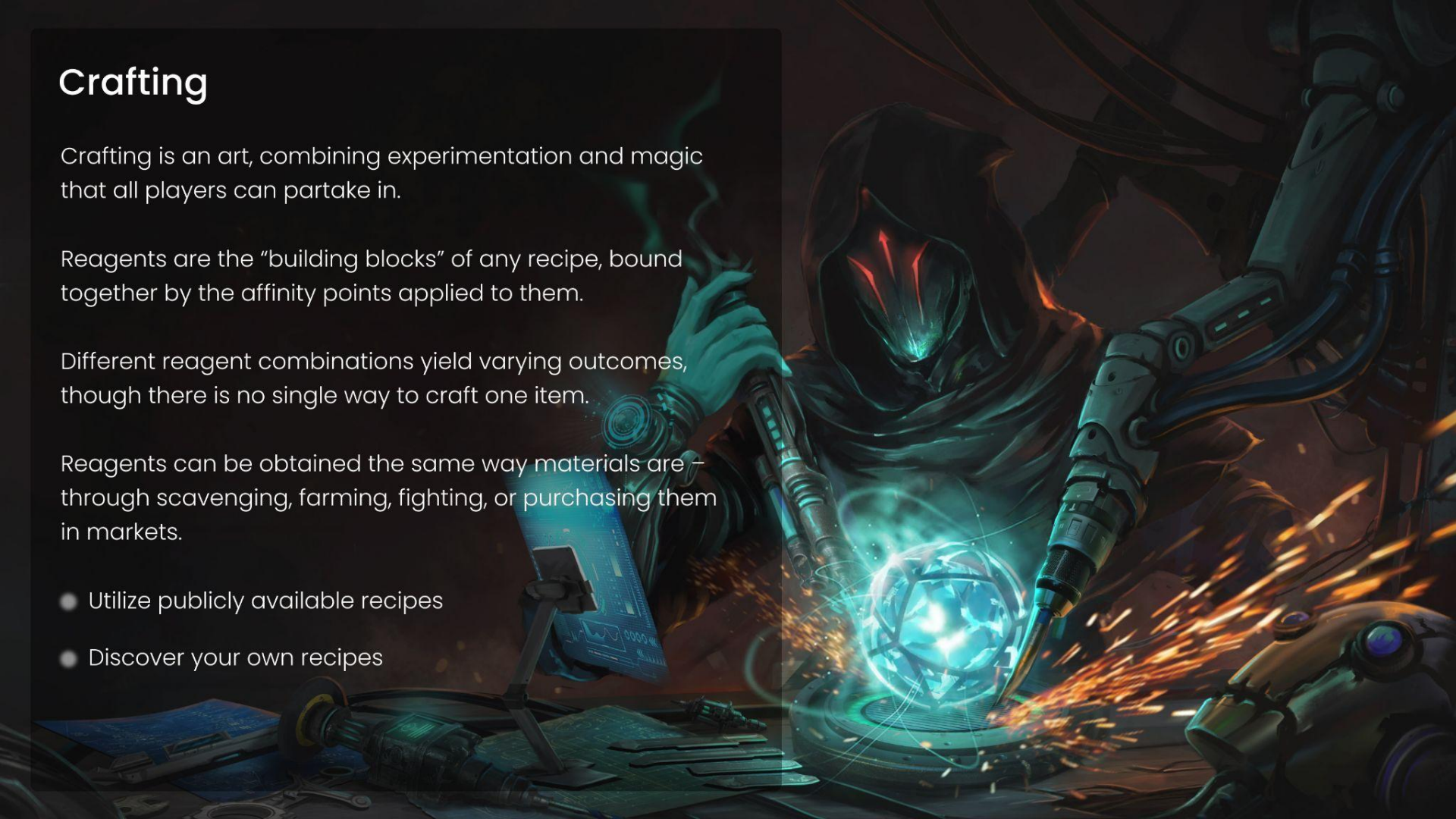
Crafting is an art, combining experimentation and magic that all players can partake in.

Reagents are the “building blocks” of any recipe, bound together by the affinity points applied to them.

Different reagent combinations yield varying outcomes, though there is no single way to craft one item.

Reagents can be obtained the same way materials are – through scavenging, farming, fighting, or purchasing them in markets.

- Utilize publicly available recipes
- Discover your own recipes

# Realm Wonder NFT

## Keep the power to surpass others

Constructing Realm Wonders like Teleportation portals or Fountains of Youth unlocks unique capabilities exclusively available to owners.

## Share the power for a price

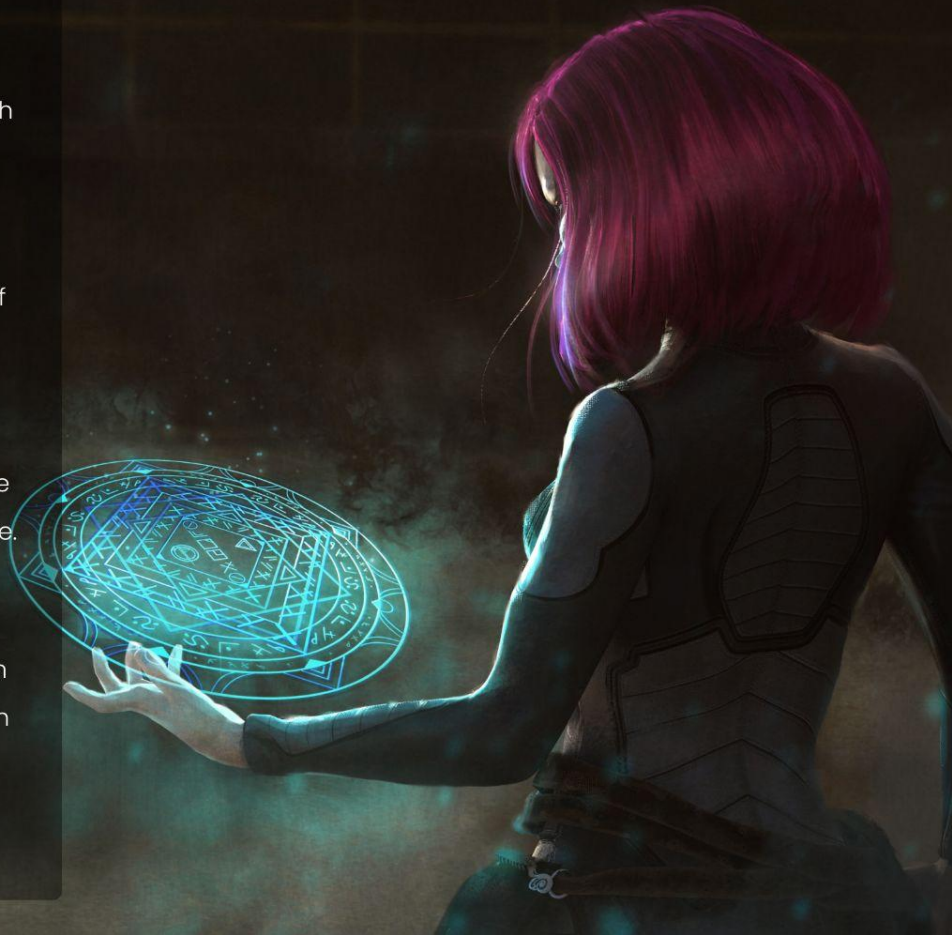
Realm Wonders grant positive effects upon the owner or fulfill the desires of other players – for a price.

## Passive income for Founding Players

Founding Players are contributors of extremely valuable Realm Wonders like the Arena. They own a fraction of the whole NFT and receive passive income.

Single-handedly constructed Realm Wonders as well as Founder's NFTs can be sold to other players and investors including all the perks that come with owning the Wonder.

Discovering Protospells lets the owner craft powerful items that are exclusively available to them. They can then exploit this power to excel at in-game activities where the competition is fierce.

## Share the power for a price

Items produced with Protospells can also be sold on the market, evening up the playing field and yielding profit for the owner.

## Sell Protospells in auctions

All Protospells are valuable assets since their discovery is no easy task. The items they produce will always have a use for the owner or for the buyer.

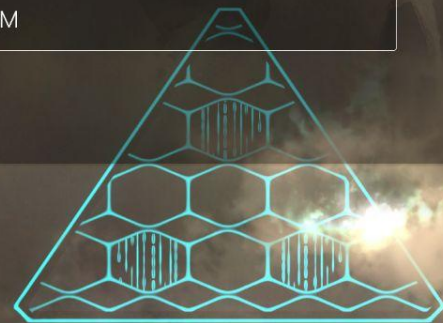

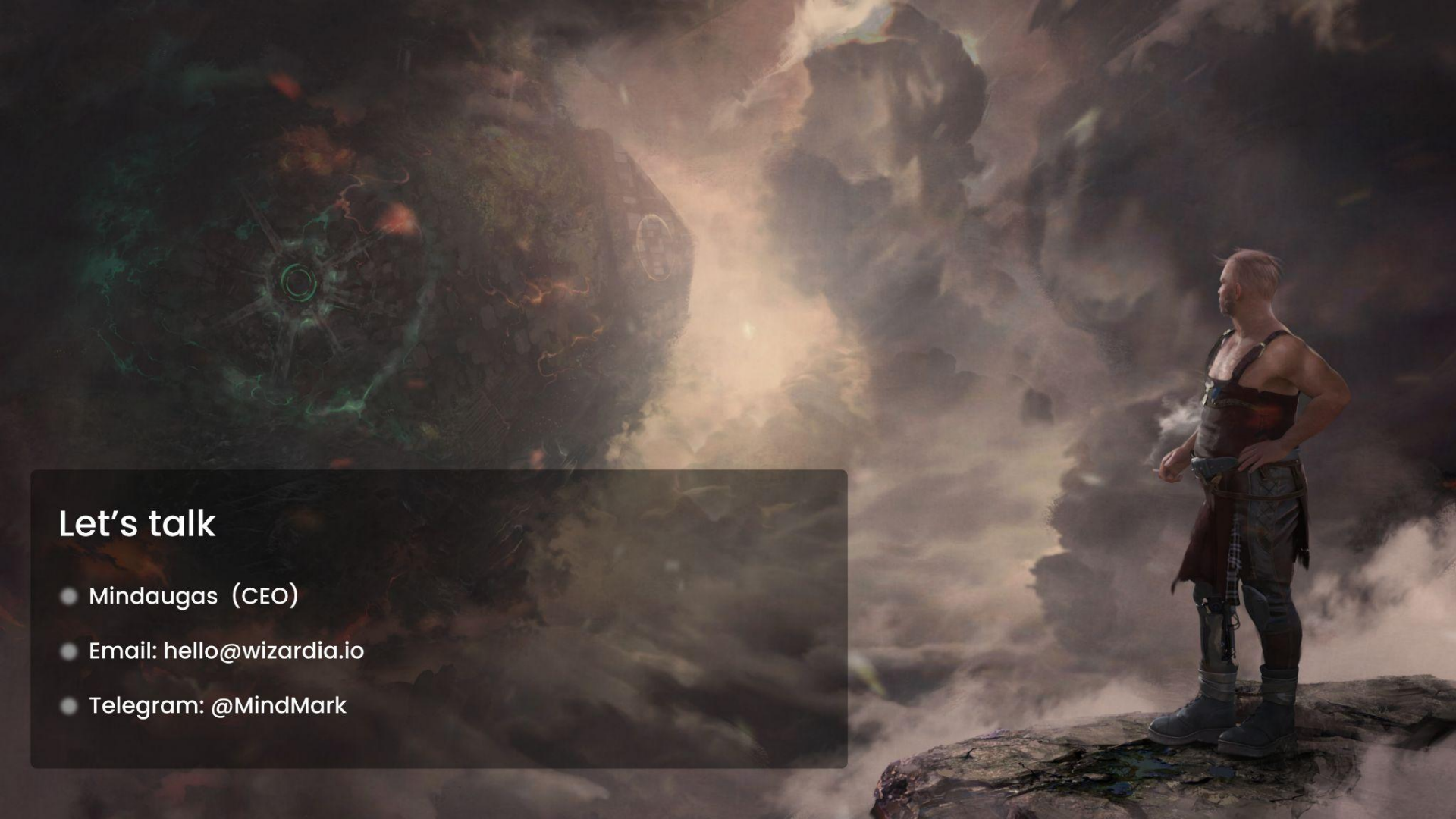
